## WHAT DOES LIBERTY BANK FOR SAVINGS DO WITH YOUR PERSONAL INFORMATION?

How?	All financial companies need to share <b>customer's</b> personal information to run their everyday business. In the section below, we list the reasons financial companies can share their <b>customer's</b> personal information; the reasons <b>Liberty Bank for Savings</b> chooses to share; and whether you can limit this sharing.
